SPECIFIC OBJECTION Determination Hearing
held Tuesday, April 26, 2022

MEETING MINUTES

- 1) The meeting was called to order at 10:00 AM by Commissioner Darlene Harris. The meeting was held for the purpose of determining the validity of the specific objections of Phyllis Amrick to Petition 2022000173 [Democratic Party County Committee member representing Niskayuna ED# 6] of David Rossman.
- 2) Darlene Harris nominated Holly Van Schaick as recording secretary; Seconded by Amy Hild. Unanimous voice vote.
- 3) Explanation of the rules and the process of objecting to petitions at the Board of Elections.
- 4) No further documents were submitted as evidence to be considered by the Board of Election Commissioners.
- 5) Commissioners' review of objection specifications:
 - 17 signatures were required for the petition to be valid.
 - 18 signatures were submitted.
 - 4 signatures were objected to by objector Phyllis Amrick.
 - 4 signatures were sustained as invalid signatures.
 - 18 – 4 = 14 valid signatures remaining.
- 6) DETERMINATION:
 - Since the petition of David Rossman does not have the required 17 signatures, his petition does not stand.
- 7) Motion to Adjourn at 10:07 by Amy Hild; seconded by Darlene Harris. Unanimous voice vote.

Petition Number(s): 2022000173

The petition at issue requires 17 valid signatures.
The petition contained, prima facie, 18 signatures.

After a public meeting on **Tuesday, April 26, 2022** at which any interested party could appear and be heard, and upon due notice, the commissioners found 4 signatures invalid. The commissioners split on 0 signatures.

Accordingly, the petition contains 14 valid signatures, less than required by law and is thus invalid. The aforesaid candidate **shall not** appear on the **Democratic Party** primary ballot. The commissioners' worksheets indicating the disposition of each objected to signature are attached hereto and incorporated herein. The determination was announced at the meeting held on **Tuesday, April 26, 2022**.

LIMITATION OF TIME TO SEEK COURT REVIEW: A court proceeding to validate a designating petition invalidated by the board of elections can only be commenced within 3 business days of the determination of invalidation. **SEE ELECTION LAW SECTION 16-102**
