WHEREAS, The County of Schenectady is rightly proud of its many Irish residents, whether they are immigrants or descendants of immigrants, as well as their many contributions to the general welfare of Schenectady County; and

WHEREAS, The John F. Kennedy Division 1, Ancient Order of Hibernians together with the John F. Kennedy Division 1 Ladies Ancient Order of Hibernians has in fact contributed to the general welfare of the County of Schenectady for over 143 years and 129 years, respectively, by its many financial donations and the performance of various good works for worthy causes and deserving organizations; and

WHEREAS, on April 10, 1998, the Government of Ireland and the Government of the United Kingdom signed the Good Friday Agreement, also known as the "Belfast Agreement", with goals to bring a new era of devolved government and democracy to Northern Ireland, end violence, and ensure peace for the people of the island of Ireland; and

WHEREAS, the successful negotiation of the Good Friday Agreement stands as a historic and groundbreaking success that has proven critical to the decades of relative peace that have followed, and the return to power sharing creates new opportunities for strengthening peace and reconciliation in Northern Ireland: and

WHEREAS, the agreement between the United Kingdom and the European Union on the withdrawal of the United Kingdom from the European Union, and the protocol to that agreement on Northern Ireland preserving an open border on the island of Ireland (in this preamble referred to as the "Northern Ireland Protocol"), are intended to protect the peace forged under the Good Friday Agreement; and

WHEREAS, despite the historic progress of the Good Friday Agreement and subsequent agreements, including the Stormont House Agreement agreed to in December 2014, important issues remain unresolved in Northern Ireland, including the passage of a Bill of Rights, securing justice for all victims of violence, including violence by state and non-state actors, and reducing sectarian divisions and promoting reconciliation; and

WHEREAS, the reintroduction of barriers, checkpoints, or personnel on the island of Ireland, also known as a "hard border", including through the invocation of Article 16 of the Northern Ireland Protocol, would threaten the successes of the Good Friday Agreement; and

WHEREAS, the Schenectady County Legislature stands steadfastly committed to supporting the peaceful resolution of any and all political challenges in Northern Ireland; Now, therefore, be it

#### RESOLVED, that the Schenectady County Legislature:

- (1) supports dialogue and negotiation between all parties to maintain peace;
- (2) supports the full implementation of the Good Friday Agreement to ensure peace and stability on the island of Ireland;
- (3) supports efforts that the involved parties fully implement the Northern Ireland Protocol as agreed upon in the interest of maintaining peace and stability on the island of Ireland;
- (4) supports efforts that the people of Northern Ireland foster further integration across communities and break down cultural, religious, and societal barriers that remain;
- (5) supports the devolved government of Northern Ireland and recognizes the devolved government as a successful outcome and tenet of the Good Friday Agreement; and, be it further

**RESOLVED**, that the Schenectady County Legislature declares that on March 17, 2023, St. Patrick's Day shall be celebrated throughout the County of Schenectady in recognition of the many contributions and good works of Irish American people everywhere.

A RESOLUTION REQUESTING THE NEW YORK STATE LEGISLATURE TO APPROVE A SPECIAL LAW TO EXTEND THE AUTHORITY OF SCHENECTADY COUNTY TO ENACT THE "2023 SCHENECTADY COUNTY HOMEOWNERS \$250 REBATE PROGRAM"

**BE IT ENACTED,** by the Legislature of the County of Schenectady, as follows:

WHEREAS, Assembly Bill number 5346 and Senate Bill number 5607 would authorize the County of Schenectady to adopt and amend local laws to grant a taxpayer assistance payment to all eligible households within the County for the County fiscal year 2023 in an amount not to exceed two hundred fifty dollars (\$250.00); now, therefore, be it

**RESOLVED**, that a home rule request is made to the New York State Legislature as follows:

#### TO THE LEGISLATURE:
