RESOLUTION 97-23

Sponsored by the Committee on Rules:

A RESOLUTION REQUESTING THE NEW YORK STATE LEGISLATURE TO APPROVE A SPECIAL LAW TO EXTEND THE AUTHORITY OF SCHENECTADY COUNTY TO ENACT THE “2023 SCHENECTADY COUNTY HOMEOWNERS \$250 REBATE PROGRAM”

BE IT ENACTED, by the Legislature of the County of Schenectady, as follows:

WHEREAS, Assembly Bill number 5346-A and Senate Bill number 5607-A would authorize the County of Schenectady to adopt and amend local laws to grant a taxpayer assistance payment to all eligible households within the County for the County fiscal year 2023 in an amount not to exceed two hundred fifty dollars (\$250.00); now, therefore, be it

RESOLVED, that a home rule request is made to the New York State Legislature as follows:

TO THE LEGISLATURE:

Pursuant to Article IX of the State Constitution, the County of Schenectady requests the enactment of Assembly Bill number 5346-A and Senate Bill number 5607-A, entitled “AN ACT providing for a taxpayer assistance authorization for households in the county of Schenectady”

It is hereby declared that a necessity exists for the enactment of such legislation, and that the facts establishing such necessity are as follows:

The local government does not have the power to enact such legislation by local law.

Such request is made by the chief executive officer of such municipality concurred in by a majority of the total membership of the local legislative body; and, be it further

RESOLVED, that the Clerk of this Legislature be and he hereby is directed to process a home rule request with the New York State Senate and Assembly and to take whatever additional steps are necessary to implement this Resolution.
