
Possibilities Abound

Tanner, a Senior in high school, was unsure whether he wanted to pursue college but instead, with the help of our staff, connected with the Carpenter's Union Pre-Apprenticeship Program. He will complete 160 hours of training and have a secure job with the Carpenter's Union and a \$400 professional tool set - all before graduating from high school.



Our staff at Washington Irving Educational Center assist people for whom English is a second (or more) language in finding employment. This can be daunting when most of our area's workforce is English-speaking. Recently, 3 of these students found gainful employment with Schenectady City School District and Amazon.



Olivia was referred to our Job Readiness Training as a mandate for receiving Public Assistance benefits. She was homeless and driving for InstaCart to support her family but eagerly engaged in all of the services Schenectady County Connects has to offer. Olivia soon obtained a career at NYS Department of Tax and Finance and was also able to secure an apartment for herself and her family.

2024 Workforce Advocacy Benefits Cliff Updates

When an individual or family receiving Public Assistance obtains employment, this income impacts the amount of assistance they continue to be eligible for and often renders them ineligible for assistance, closing their case. This sudden removal of benefits is what is termed the "benefits cliff" where consistent, reliable public income is no longer present and the family has to navigate the financial and emotional implications of budgeting, saving and relying on themselves to ensure they remain financially stable.

Our advocacy agency, NYATEP is encouraging the following items to be included in the State budget to minimize the "cliff effect" impact many New York families face:

- "The establishment of a task force to study fiscal benefit cliffs in New York state's Public Assistance Program and make recommendations to reduce and eliminate such fiscal cliffs and the \$500,000 in funding for OTDA for expenses incurred for the study."
- "Increase the income threshold to 400% from 200% of the Federal Poverty Level for the one-time, six-month earned income disregard for public assistance recipients who enter a job after completing an employment training program."
